Organisers will endeavour to give entrants the required space, however there may be some limitations due to site dimensions and site plan

Conditions of Entry

- Payment must be attached to application – or verified (ie: for direct deposit) PRIOR to the event.
- Closing date for ALL competitions is 10th July 2009.
- All competitions entrants must go to the Hoof Street entrance and enter the Show & Shine Arena. Please note that you cannot enter before 6:30am
- You will receive your allocated display space by the attendants on the day. NO changes will be allowed.
- All competition entrants must be parked in the Show & Shine Arena NO LATER than 9:30am. Entries arriving after this time will not be permitted to participate and there will be no refund of entry fees
- Judging begins 10:30am
- All Vehicles must be registered and street legal (road worthy) to enter the site and competitions – unless otherwise specified.
- Vehicles transported to the event must be unloaded outside the event site. All vehicles must be driven into the site
- No more than 2 categories per vehicle
- Vehicles will be required to be driven to the Show & Shine Arena; therefore drivers must be under the legal alcohol limit. NSW road rules will be enforced throughout the weekend both on site and around the area.
- Attendees at the 2009 Grafton Car Show assume full responsibility and accept full liability for their own health, well-being, safety, physical actions and the result of all their actions.
- Failure to comply with rules and parking instructions will result in automatic disqualification from the competition and forfeiture of entry fee.
- Prize presentation will commence at (approx) 2:00pm
- The judges decision is final and NO discussion will be entered into
- NO vehicle is permitted to be removed from the site prior to 3:00pm
- Site Marshalls will guide all vehicles leaving the event

Note: Entry criteria and conditions must be strictly adhered to.
